Chapter 5: The Cell Cycle

1. The cell cycle is a series of events that a cell goes through to divide and produce two daughter cells. It is a continuous cycle that repeats itself.

2. The cell cycle is divided into two main phases: interphase and mitosis. Interphase is the longest phase and is further divided into three stages: G<sub>1</sub>, S, and G<sub>2</sub>.

3. During interphase, the cell grows and carries out its normal functions. In the G<sub>1</sub> phase, the cell increases in size and synthesizes proteins. In the S phase, DNA replication occurs, resulting in two identical copies of each chromosome.

4. In the G<sub>2</sub> phase, the cell continues to grow and prepares for division. The DNA is checked for errors, and any damage is repaired.

5. Mitosis is the process of cell division that results in two daughter cells. It is divided into four stages: prophase, metaphase, anaphase, and telophase.

6. In prophase, the chromosomes condense and become visible. The nuclear envelope breaks down, and the spindle fibers begin to form.

7. In metaphase, the chromosomes align in the center of the cell, forming the metaphase plate.

8. In anaphase, the sister chromatids separate and are pulled toward opposite poles of the cell by the spindle fibers.

9. In telophase, the nuclear envelopes reform around the two sets of chromosomes, and the spindle fibers break down.

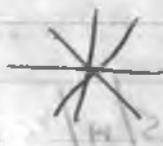
